The Governor of Punjab is pleased to approve the revision in royalty rates from 2003-04 to 2006-07 as under: –

Note: 1. Royalty rates of dead, dry and fallen trees will be at 65% of green standing trees.
 2. Poplar trees are proposed to be purchased on commission basis as under:-
 (i) Rs.300.00 per cubic meter of standing volume for felling conversion, transportation and depot charges etc.
 (ii) 2% commission on the net sale proceeds after deducting felling charges as above.

2. So far as reduction in the rate of interest from 12% to 7% on pending of royalty is concerned, you are requested to indicate financial implications of the proposal.

3. This issues with the concurrence of the Finance Department conveyed vide its I.D.No.7/12/87/5FE-3/1931 dated 29.09.2006.
